### Our Business

Our business, as the Head Office of Skyjack's international operations based in Oswestry, UK, supplies MEWPs (finished goods) and spare parts together with the provision of related services to customers in the UK, mainland Europe, the Middle East and the Far East.

### Our Supply Chains

Skyjack UK Ltd.'s supply chain predominantly comprises purchases from our parent company Skyjack Inc. based in Canada and from two fellow subsidiary company's, being Skyjack St. Charles and Skyjack South West both based in the USA (spare parts only).

### Our Policies on Slavery and Human Trafficking

We are committed to ensuring that there is no modern slavery or human trafficking in our supply chains or in any part of our business. #### **Supplier Adherence to Our Values and Ethics**

We have zero tolerance to slavery and human trafficking. To ensure all those in our supply chain and contractors comply with our ethics we have in place a supply chain compliance programme. This consists of: Terms and Conditions of Business, Codes of Conduct, Whistleblowing Policy and an Anti-bribery and Corruption Policy.

We have a dedicated compliance team, which consists of representatives from the Legal, Audit & Compliance, Human Resources, Procurement and Sales departments.

We use the following key performance indicators (KPIs) to measure how effective we have been to ensure that slavery and human trafficking is not taking place in any part of our business or supply chains:

- Annual review of supply chains.
- Training provided to all employees, workers and contractors on induction on our Anti-slavery and Human Trafficking, Anti-bribery and Corruption and Whistleblowing Policies and Procedures.
- Annual policy and risk assessment reviews.
